**Finance Chair:** VFMC Finance Chair Wendell Anderson presented 8 proposals that were presented and accepted by the Finance Committee

- Renew the \$1,000 annual honorarium for VFMC Representative to NFMC Board for the 2023 Biennium. Motion to accept proposal by Kathryn Peters.

- 2. Renew the \$1500 honorarium for VFMC —elected Member-at-large nominees who are elected to the NFMC Board for the 2023-25 biennium. Honoraria will be divided among the elected VFMC nominees. Allocation not to exceed \$1,000 if only one VFMC nominee is elected and/or attends national meeting. Motion to accept proposal by Elin Havrilla. Motion Carried
- 3. Propose honoraria for official attendees at the NFMC meetings 2023-25: \$200 for NFMC chairs; \$125 for member registration. Rationale: The \$200 for NFMC Chairs is a renewal policy. The \$125 member registration for national meetings reflects the new 2023 NFMC registration fee (From previous \$100 to current \$125). Motion to accept proposal by Susan Tury.

- 4. A \$50 honorarium for NFMC Young Artist at the 2024 VFMC Convention. Scheduled convention meals and lodging are provided. Rationale: To place parameters on YA expenditures. Motion to accept proposal by Kathryn Peters.

- 5. A \$2 increase in Sr. Club dues (current \$15 to become \$17 per-member minus Life Members) to balance \$2 NFMC increase in 2023. Increased dues to begin July 1, 2024. Rationale: To stabilize VFMC income following the \$2 increase in NFMC 2023-24 dues. Motion to accept proposal by Nathalie Steinbach.

- 6. A \$5 increase in the Required Convention fee per Senior Club (current \$20 to become \$25) to support increasing convention host expenses. Increased fee to begin July 1, 2024. Rationale: Hotel meeting room rates/printing expenses continue to increase, causing financial hardships on host districts. Motion to accept proposal by Nancy Turner.

- 7. A \$1 increase in Jr. Club Dues (\$35 to \$36 for the first 16 students) beginning July 1, 2024.

  Rationale: This is to maintain coverage of the gold cup expense. Motion to accept proposal by Jane Cole.

- 8. A \$5 increase in VFMC Dance Competition entry fee (current \$20 to become \$25 per entrant). Rationale: This is to bring it more in line with entry fees for other VFMC competitions. Motion by Kathryn Peters to amend proposal for the increased fee to begin July 1, 2024, 2<sup>nd</sup> by Wendell Anderson.

NFMC Representative at Large: Cynthia Elmore NFMC CONVENTION (JUNE 12-17-2023) Norfolk, VA Report from Cynthia Elmore, Virginia Representative to NFMC Board of Directors Our home for the week was the Sheraton Norfolk Waterside hotel where all meetings, workshops and musical performances took place. Our first gathering was Tuesday evening as we embarked on a dinner cruise along the Elizabeth River with excellent views of ships of the Navy's Atlantic Fleet. On Wednesday the convention opened with our first general session followed by the Regional Luncheons. We (Virginians) are members of the Southeastern Region with Joel Adams from North Carolina presiding. The Young Artist competitions had been ongoing since Monday and the winners were presented in concert that evening. The winners are Michael Celentano (tenor), Leland Philip Ko (cellist), Krista Renee Pape (soprano) and Anna Han (piano). Our afternoon began with the Festival Chorus Concert---NFMC members who had signed up to be in the choir had been practicing since Tuesday and their final concert was spectacular. Various Committees and divisions had afternoon meetings. The formal banquet honoring State Presidents concluded with Installation of officers for 2023-2025. To close our very busy day a concert was presented by Matthew Sabatella. His music illuminates the between music and the story and people of the United States. Saturday began with the Memorial Breakfast--- a time to remember those NFMC members we have lost during the past year. The service was led by NFMC Chaplain Karen Herndon. The NFMC Board met for the final time of the convention. We were treated to Garima Patel sharing her winning NMW essay for Virginia. She is 12 years old and lives in Salem, Virginia. Junior Day was also being held this morning with composer Jeremiah Evans conducting a workshop for junior composers and their teachers. The convention adjourned at noon. NFMC Convention 2024 will be held June 11-15 in Davenport, lowa. The music was spectacular and business sessions were efficient and informative.
